Payment system for dossier management for higher education applications

In December 2017 and April 2018, the Board of Governors approved a payment system for "Dossier Management" for higher education applications from September 2020 (Doc. 2020-06-M-3-en).

A fee must be paid for the processing of applications to those higher education institutions that require individual applicants to submit detailed files needing accurate and time-consuming dossier management, which in some cases is through application platforms.

This is a one-off non refundable payment.

Fees

€130 for the processing of applications to these higher education institutions that require individual applicants to submit special application files (a "dossier", for example, The Netherlands, UK Art foundation courses...)

€260 for applications to France (PARCOURSUP)

€260 for applications to the UK (UCAS).

<u>Note</u>: The UCAS payment of €260 does NOT include the administration fee to be paid directly to UCAS.

Important

The payment must be made for EACH application. If the candidate wants to apply to the UK and France, the payment would be, for example, €260 + €260 i.e. €520.

Payment may also be required for applications to institutions in other countries that need a dossier.

Parents / Students are requested to check in advance if a dossier or extended dossier is needed. In case of doubt please contact your Career Guidance teacher.

The relevant fee must be paid <u>before the 30/09/2025</u>. If your child's orientation has not yet been decided after the summer holidays, it is preferable to make the payment in September in order to avoid any refusal of enrolment aid for the 2025/2026 school year. Please note that no other solution will be possible after this date.
